Prof. dr. Ronald Holzhacker, University of Groningen, the Netherlands, is Professor of Comparative Multilevel Governance and Regional Structure in the Faculty of Spatial Science, Department of Spatial Planning and Environment, and teaches also in the Faculty of Arts, Department of International Relations and International Organization. He holds a PhD from the University of Michigan in political science, and a *Juris Doctor* (JD) from the University of Minnesota Law School. He is broadly interested in questions of governance, human rights, sustainable cities, climate adaptation, resiliency, and the interaction between institutions and civil society in political systems. He has been a Visiting Professor in the U.S., Australia, and Europe, including at Macquarie University (Fall 2023, Fall 2024), the University of Melbourne, Political Science (Fall 2017); Monash University Melbourne, EU Centre (Spring 2013); Columbia University, Institute for the Study of Human Rights, New York (Spring 2010), and taught a course on 'Comparative Democratic Institutions' at the University of Paris 1, Sorbonne, Department of Political Science (Spring 2005). He held a Jean Monnet Fellowship for research at the European University Institute in Florence (EUI) (Winter-Spring 2006), and was a DAAD recipient for research at the Wissenschaftszentrum Berlin für Sozialforschung (WZB) (1994-1996).

He is founding Director of the Groningen Research Centre for Southeast Asia and ASEAN (SEA ASEAN <a href="https://www.rug.nl/research/ursi/sea-asean/?lang=en">https://www.rug.nl/research/ursi/sea-asean/?lang=en</a> ) located in Groningen and Gadjah Mada University, Yogyakarta, Indonesia. He leads an inter-disciplinary team of scholars and 32 PhD current and alumni researchers engaged in theoretically driven comparative research focused on governance, societal impact, and sustainable society in Southeast Asia. He is published in such journals as Law & Policy, Comparative European Politics, Journal of European Integration, European Union Politics, Nations and Nationalism, Party Politics, Journal of Legislative Studies, European Journal of Comparative Law and Governance, Journal of Asian Economic Integration, Journal of Southeast Asian Human Rights, Regional Environmental Change, Contemporary Southeast Asia, and the Asia Pacific Journal of Public Administration. The SEA ASEAN Centre is part of an Erasmus+ grant from the EU to improve the capacity to conduct social science research in Southeast Asia (681.035 Euro). Specifically, the BRECIL consortium aims to develop human and social capital to facilitate individual learning and institutional mechanisms in social science research in higher education institutions in Malaysia and Laos. The grant allows SEA ASEAN to play a key role in facilitating capacity building and research governance in the region.

He is co-editor of numerous books over the past decade focused on Southeast Asia, including *Transformative City Futures: Sustainable Development and Climate in Southeast Asia* (Leiden, Singapore, Boston: Brill, forthcoming 2024), *Challenges of Governance, Development and Regional Integration in Southeast Asia and ASEAN* (NY: Springer 2021), *Sustainable Development Goals in Southeast Asia: Regional and National Approaches* (Leiden, Singapore, Boston: Brill 2019), and *Decentralization and Governance in Indonesia* (New York: Springer 2016) A book launch and conference for increased societal impact on these themes was held in October 2018 in Brussels, with key-note speakers from the EU, ASEAN, and UN ESCAP, and professors and PhD candidates from across the region. He is a frequent visitor to SE Asia, delivering lectures and meeting with scholars at the SE Asian and ASEAN centres at the leading universities in the region.

He recently organized a major international conference 'Transformative Futures: International Climate Change and Sustainable Development, Challenges of Implementation in Cities in Southeast Asia' (Clim/Sust SE Asia 2023 <a href="rug.nl/transformative-futures-2023">rug.nl/transformative-futures-2023</a>) and has submitted an edited volume on these themes to Brill publishing The conference and graduate workshop was organized by the University of Groningen, Thammasat University (Thailand) and Gadjah Mada University (Indonesia) in Bangkok March 14-17, 2023. The conference was interdisciplinary in scope, and focused on societal impact of research with outreach to public officials and policymakers from the Netherlands, Thailand, Indonesia, as well as the EU and ASEAN.

His work across Southeast Asia and the Asia Pacific will be further deepened in the coming years with his appointment as 'Distinguished Research Fellow' to Macquarie University, Centre for Environmental Law, for an initial period from March 2024 until end of 2025.
