2. Working method

2.1. General

The CUOS operates in accordance with the CUOS Regulations, and this provisional decision is based on the task of assessing organizations that seek to qualify for activity grants and/or housing from the University according to the conditions set out in Article 9 of the CUOS Regulations (Art 2 paragraph 1 sub a). This also takes into account the guidelines for applying for activity grants and housing. After the publication of this document, each organization will receive a letter containing the preliminary decision. In accordance with the CUOS Regulations (Art 10, paragraph 6), the CUOS gives the party concerned the opportunity to take note of the proposed decision and the opportunity to express their views within 10 working days. If the party concerned does not submit a view within this period, this provisional decision becomes final. If the party concerned does submit a view within this period, the CUOS will take a final decision as soon as possible and the organization will be notified of that decision, which may or may not be revised.

2.2. Deadline

At the beginning of this academic year, the CUOS approached all the organizations that the CUOS either suspected or knew wanted to apply for activity grants and/or housing. All these organizations received an additional reminder by e-mail shortly before the deadline on 1 February. Organizations could submit an application before 1 February. Additional documents were still being collected in the first few weeks after the deadline. The CUOS generally enforces a hard deadline. Exceptions may be made in special circumstances. This year, all applications were processed.

2.3. Assessment

The applications were assessed in accordance with the conditions listed in the CUOS Regulations Article 9, the Guidelines for applying for Activity Grants and Housing (CUOS Guidelines), and the Cluster and Quality Characteristics. It should be emphasized that the CUOS reviews the organizations based on the information provided and on any requested information. No assessment can be made based on documents that were not provided.

3. Activity Grants and Housing Overview

An overview of the requested and awarded Activity Grants and Housing for 2024 can be found below.

3.1. Activity Grants Overview

The table below provides an overview of the amount of activity grants requested and awarded per organization. A detailed argumentation for each organization can be found from Chapter 4 onwards.

^{*}Student facilities receive an annual fixed activity grant. These organizations are provided with housing by the CUOS if they have no other arrangements.

** Allocated amount of €30,000 plus incidental increase.

The CUOS notes that:

Student facilities, marked with an asterisk, do not need to apply because their activity grant is fixed and does not require argumentation. This grant does not aim to compensate for losses or increase in equity. The CUOS does take into account the financial situation and the financial need for support for organizations. The processing of applications for an incidental increase in activity grants for student facilities, other than Stichting KEI, has not yet been concluded.

The funds will be disbursed after the final decision. Activity grants can be submitted for calendar years 2024 or 2025, as well as for academic years 2023-2024 or 2024-2025. However, this document always refers to allocation for 2024 because the UG's financial year runs from 1 January to 31 December.

3.2. Housing Overview

The CUOS assessed all housing applications using the CUOS Guidelines and, in particular, the housing Calculation Model. All organizations that were provided with housing by the CUOS last year have also applied for housing this year. Additional applications have also been made and, since 2 of them have been approved, changes have been made to the housing arrangements as per Article 13(b). The need for potential housing was also considered this year. An informed decision was made based on the information provided. Table 1 lists the organizations that have been allocated housing for the coming year. Table 2 shows the suggested distribution of housing for the next academic year. The table shows location, room number, and the number of allocated workspaces.

4. Individual decisions

4.1. African Caribbean Student Association (ACSA)

Organization

The organization ACSA (African Caribbean Student Association):

- belongs to the Internationalization cluster;
- did not apply for an activity grant last year;
- is applying for a €2,431 activity grant for this year;
- is applying for housing for this year;
- submitted their application in time and in full.

Assessment Activity Grant

The CUOS has assessed that ACSA:

- DOES meet the general conditions;
- DOES conduct a clear and consistent financial policy;
- DOES demonstrate a financial need for support from the CUOS.

The CUOS has decided to allocate €640 to ACSA for 2024. The CUOS allocates this amount towards the International dinner, Symposium 2024, and field trip. The CUOS emphasises that ACSA itself could do more to generate funds, for example by charging a membership fee. The CUOS does not allocate funds for social purposes that are not substantive.

Assessment Housing

The CUOS has assessed that ACSA:

HAS demonstrated a need for housing.

ACSA organizes some activities on an annual basis. In addition, ACSA contributes to a positive image of the University and the city of Groningen. This is the first year ACSA has applied for housing through the CUOS. Therefore, the CUOS believes it is important to stress that in the coming year, there will be a careful evaluation of whether ACSA makes sufficient use of the office.

Decision Housing

The CUOS has decided to allocate 2 workspaces to ACSA to share with GSb in room 119 at Oude Kijk in 't Jatstraat for the year 2024-2025.

4.2. AEGEE-Groningen

Organization

The organization Association des États Généraux des Étudiants de l'Europe - Groningen (AEGEE-Groningen)

- belongs to the Internationalization cluster;
- received €4,000 of a requested €4,000 activity grant last year;
- is applying for housing for this year;
- is applying for a €4,500 activity grant for this year;
- submitted their application in time and in full.

Assessment Activity Grant

The CUOS has assessed that AEGEE:

- DOES meet the general conditions;
- DOES conduct a clear and consistent financial policy;
- DOES demonstrate a financial need for support from the CUOS.

The CUOS has decided to allocate €4,500 to AEGEE for 2024. The CUOS allocates this amount for the benefit of substantive activities organized by several committees that contribute to a positive image of the University. CUOS does stress that next year, AEGEE should send in a clearer breakdown of costs, and include only the specific activities for which they are applying for activity grants.

Assessment Housing

The CUOS has assessed that AEGEE:

HAS demonstrated a need for housing.

The organization's board members have a significant administrative burden that requires housing. They make great use of the workspaces they were allocated in previous years. The organization does not have any claim on a space from a faculty and does not have the resources to provide the space itself.

Decision Housing

The CUOS has decided to allocate 4 workspaces to AEGEE in room 116 at Oude Kijk in 't Jatstraat for the year 2024-2025.

4.3. AIESEC

Organization

The organization AIESEC (AIESEC Groningen):

- belongs to the Internationalization cluster;
- did not apply for an activity grant last year;
- is applying for a €500 activity grant for this year;
- is applying for housing for this year;
- submitted their application in time and in full.

Assessment Activity Grant

The CUOS has assessed that AIESEC:

- DOES meet the general conditions;
- DOES conduct a clear and consistent financial policy;
- DOES demonstrate a financial need for support from the CUOS.

The CUOS has decided to allocate €500 to AEGEE for 2024. The CUOS allocates this amount for room rental subsidy.

Assessment Housing

The CUOS has assessed that AIESEC:

- DOES meet the general conditions;
- HAS demonstrated a need for housing.

The space allocated to AIESEC by the CUOS has been extensively used in recent years. This space is often used, not only the full-time board, but by the part-time directors as well. AIESEC does not have any claim on space from a faculty and does not have the resources to provide the space itself. Also considering the international aspect of AIESEC, the organization contributes to a positive image of the University and the city of Groningen. As a result, the CUOS has decided to increase the number of workspaces to 7.

Decision Housing

The CUOS has decided to allocate 7 workspaces in rooms 116 and 220 at Oude Kijk in 't Jatstraat for 2024-2025.

4.4. De kleine consultant

Organization

The organization De kleine consultant:

- belongs to the Promoting Student Interests cluster;
- did not apply for an activity grant this year;
- is applying for housing for this year;
- submitted their application in time and in full.

Assessment Housing

The CUOS has assessed that De kleine consultant:

- DOES NOT meet the general conditions;
- HAS NOT demonstrated a need for housing.

De kleine consultant has applied for housing. This application shows that their articles of association do not state that De kleine consultant is aimed at students from Groningen and that their board consists exclusively of students. This is not in accordance with the requirements of the CUOS regulations in Article 9 paragraph 1.c.i and 1.c.ii.

Decision on Housing

The CUOS had decided NOT to grant housing. The CUOS has assessed that De kleine consultant does not comply with the general conditions laid down in the CUOS regulations.

4.5. Enactus

Organization

The organization Enactus Groningen:

- belongs to the Promoting Student Interests cluster;
- received €800 of a requested €800 activity grant last year;
- is applying for a €1,300 activity grant for this year;
- is applying for housing for this year;
- submitted their application in time and in full.

Assessment Activity Grant

The CUOS has assessed that Enactus Groningen:

- DOES meet the general conditions;
- DOES conduct a clear and consistent financial policy;
- HAS spent last year's activity grant effectively;
- HAS demonstrated a financial need for support from the CUOS.

Decision Activity Grant

The CUOS has decided to allocate €1,300 to Enactus for 2024. The CUOS allocates this fund for hiring speakers for the symposium and substantive activities. The CUOS does note that Enactus' undesignated capital is far too high and should remain below 20% of their budget total, according to the CUOS regulations article 7 paragraph 1b. Next year, there should be a reduction, ensuring that this equity is systematically reduced. Otherwise, there may be consequences for the allocation of subsequent grant applications.

Assessment Housing

The CUOS has assessed that Enactus:

- HAS demonstrated a need for housing.

Enactus has again submitted an application for housing. This application shows that they are a part-time board. Enactus does not have any claim on space from a faculty and does not have the resources to provide the space itself. Despite the part-time nature of the board, the CUOS believes that allocating an own office instead of a flex office could have a positive impact on the board's work.

Decision on Housing

The CUOS has decided to allocate 2 workspaces to Enactus in room 219 at Oude Kijk in 't Jatstraat for the year 2024-2025.

4.6. Ganymedes

Organization

The organization Ganymedes LGBT studentenvereniging Groningen:

- belongs to the Promoting Student Interests cluster;
- did not apply for an activity grant last year;
- does not apply for an activity grant this year;
- is applying for housing for this year;
- submitted their application in time and in full.

Assessment Housing

The CUOS has assessed that Ganymedes:

- DOES meet the general conditions;
- HAS demonstrated a need for housing.

Ganymedes organizes some activities on an annual basis. In addition, Ganymedes contributes to a positive image of the University and the city of Groningen. Ganymedes has also demonstrated that they have a significant administrative burden and make use of the office that was allocated to them last year.

Decision Housing

The CUOS has decided to allocate 2 workspaces to Ganymedes to share with DVS in room 210 at Oude Kijk in 't Jatstraat for the year 2024-2025.

4.7. Groningen Indian Students Association (GISA)

Organization

The organization GISA (Groningen Indian Students Association):

- belongs to the Internationalization cluster;
- received €0 of a requested €1,000 activity grant last year;
- is applying for a €1,000 activity grant for this year;
- is applying for housing for this year;
- submitted their application in time and in full.

Assessment Activity Grant

The CUOS has assessed that GISA:

- DOES NOT meet the general conditions; Just like in last year's activity grant application, GISA did not provide statutes that comply with CUOS Regulations Art.91.c.ii. This means that GISA does not meet the general condition that the executive board of the organization should consist of students or grantees from Groningen.
- DOES conduct a clear and consistent financial policy;
- HAS demonstrated a financial need for support from the CUOS.

Decision Activity Grant

The CUOS has decided NOT to allocate an activity grant to GISA. The CUOS has determined that GISA does not comply with the general conditions laid down in the CUOS regulations.

4.8. Groninger Studentenbond (GSb)

Organization

The organization Groninger Studentenbond (GSb):

- belongs to the Promoting Student Interests cluster;
- received €3,650 of a requested €3,650 activity grant last year;
- is applying for a €4,150 activity grant for this year;
- is applying for housing for this year;
- submitted their application in time and in full.

Assessment Activity Grant

The CUOS has assessed that the Groninger Studentenbond:

- DOES meet the general conditions;
- DOES conduct a clear and consistent financial policy;
- HAS spent last year's activity grant effectively;
- HAS demonstrated a financial need for support from the CUOS.

Decision Activity Grant

The CUOS has decided to allocate €3,950 to Groninger Studentenbond for 2024. The CUOS allocates this amount for the benefit of substantive activities organized by several committees and working groups that contribute to a positive image of the University. However, the CUOS does note that the equity is too high and should remain below 20% of their budget total, according to the CUOS regulations article 7 paragraph 1b. Next year, there should be a reduction, ensuring that this equity is systematically reduced. Otherwise, there may be consequences for the allocation of subsequent grant applications.

Assessment Housing

The CUOS has assessed that the GSb:

- HAS demonstrated a need for housing.

The GSb is an independent organization that does not have any claim on space from a faculty. They also do not have the resources to provide the space themselves. However, the board and committees need space to prepare and carry out their activities.

Decision Housing

The CUOS has decided to allocate 2 workspaces to GSB to share with ACSA in room 119 at Oude Kijk in 't Jatstraat for the year 2024-2025.

4.9. HCSA

Organization

The organization HCSA:

- belongs to the Promoting Student Interests cluster;
- is applying for housing for this year;
- does not apply for an activity grant this year;
- submitted their application in time and in full.

Assessment Housing

The CUOS has assessed that HCSA:

- DOES meet the general conditions;
- HAS demonstrated a need for housing.

HCSA organizes some activities on an annual basis that contribute to a positive image of the University. This is the first year HCSA has applied for housing through the CUOS. Therefore, the CUOS believes it is important to stress that in the coming year, there will be a careful evaluation of whether HCSA makes sufficient use of the office.

Decision Housing

The CUOS has decided to allocate 2 workspaces to share with Integrand in room 101 at Oude Kijk in 't Jatstraat for the year 2024-2025.

4.10. Integrand

Organization

The organization Integrand (Integrand Groningen):

- belongs to the Promoting Student Interests cluster;
- is applying for housing for this year;
- does not apply for an activity grant this year;
- submitted their application in time and in full.

Assessment Housing

The CUOS has assessed that Integrand:

- DOES meet the general conditions;
- HAS demonstrated a need for housing.

Integrand organizes some activities on an annual basis that contribute to a positive image of the University. Furthermore, Integrand has demonstrated that they have a significant administrative burden, and make frequent use of the office that was allocated for 2022.

Decision Housing

The CUOS has decided to allocate 2 workspaces to share with HCSA in room 101 at Oude Kijk in 't Jatstraat for the year 2024-2025.

4.11. Lijst Calimero

Organization

The organization Lijst Calimero:

- belongs to the Promoting Student Interests cluster;
- received €300 of a requested €300 activity grant last year;
- is applying for a €300 activity grant for this year;
- submitted their application in time and in full.

Assessment Activity Grant

The CUOS has assessed that Lijst Calimero:

- DOES meet the general conditions;
- DOES conduct a clear and consistent financial policy;
- HAS spent last year's activity grant effectively;
- HAS demonstrated a financial need for support from the CUOS.

Decision Activity Grant

The CUOS has decided to allocate €300 to Lijst Calimero for the year 2024. The CUOS grants this amount for the purpose of organizing Well-being Week.

Decision Housing

The CUOS has decided to allocate 2 workspaces to Lijst Calimero in room 212 at Oude Kijk in 't Jatstraat for the year 2024-2025.

4.12. SIB-Groningen

Organization

The organization SIB Groningen:

- belongs to the Internationalization cluster;
- received €10,750 of a requested €10,750 activity grant last year;
- is applying for a €12,250 activity grant for this year;
- is applying for housing for this year;
- submitted their application in time and in full.

Assessment Activity Grant

The CUOS has assessed that SIB Groningen:

- DOES meet the general conditions;
- DOES conduct a clear and consistent financial policy;
- HAS spent last year's activity grant effectively;
- HAS demonstrated a financial need for support from the CUOS.

Decision Activity Grant

The CUOS has decided to allocate €11,250 to SIB Groningen for the year 2024. The allocation is lower than requested because the amounts from Form B do not match SIB's budget.

Assessment Housing

The CUOS had assessed that SIB:

HAS demonstrated a need for housing.

The organization's board members have a significant administrative burden that requires housing. They make great use of the workspaces they were allocated in previous years. The organization does not have any claim on space from a faculty and does not have the resources to provide the space themselves.

Decision Housing

The CUOS has decided to allocate 7 workspaces in rooms 106, 106a, 107, and 102 at Oude Kijk in 't Jatstraat for the year 2024-2025.

4.13. SKLO

Organization

The organization SKLO:

- belongs to the Religious / Philosophical cluster;
- received €22,611.34 of a requested €22,611.34 activity grant last year;
- is applying for a €23,969.05 activity grant for this year;
- submitted their application in time and in full.

Assessment Activity Grant

The CUOS has assessed that SKLO:

- DOES meet the general conditions;
- DOES conduct a clear and consistent financial policy;
- HAS spent last year's activity grant effectively;
- HAS demonstrated a financial need for support from the CUOS.

Decision Activity Grant

The CUOS has decided to allocate €23,969.05 to SKLO for 2024. The distribution of the grant within the SKLO umbrella organizations can be found in the table on the next page.

¹ In the case of SKLO, the application form is incomplete. The CUOS stressed that SKLO should send in a clear breakdown of costs next year.

² In the case of O.C.S.G., the budget is not sufficient. In addition, the plans and the application form contain different amounts. The amount in the plan exceeds the amount in the application.

³ As for DEEN, the CUOS noted that DEEN's equity exceeds the 20% rule. This must be reduced. Otherwise, there may be consequences for the allocation of subsequent grant applications.

⁴ Ichtus is granted a conditional allocation. Ichthus must comply with the general conditions stated in Article 9, paragraph 1 under c of the CUOS regulations and inform the CUOS accordingly, within 1 year. If this condition is not met, the conditional allocation will be reclaimed by the CUOS.

⁵ In the case of C.S.F.R., the budget shows that the requested grant amount is higher than the actual budgeted amount.

⁶ In the case of GSV, the correct forms were not used.

4.14. SOG

Organization

The organization Studenten Organisatie Groningen (SOG):

- belongs to the Promoting Student Interests cluster;
- received €1,350 of a requested €2,000 activity grant last year;
- is applying for a €2,350 activity grant for this year;
- is applying for housing for this year;
- submitted their application in time and in full.

Assessment Activity Grant

The CUOS has assessed that the Studenten Organisatie Groningen:

- DOES meet the general conditions;
- DOES conduct a clear and consistent financial policy;
- HAS spent last year's activity grant effectively;
- HAS demonstrated a financial need for support from the CUOS.

Decision Activity Grant

The CUOS has decided to allocate €2,350 to SOG for the year 2024. The CUOS allocates this amount for the benefit of the Groningen Debate Competition, the Congress, and other substantive activities.

Assessment Housing

The CUOS has assessed that SOG:

HAS demonstrated a need for housing.

The CUOS believes that the SOG board and faction need a workspace to carry out their activities and have not been able to meet this need themselves through a faculty or their own resources.

Decision Housing

The CUOS has decided to allocate 2 workspaces in room 209 at Oude Kijk in 't Jatstraat for the year 2024-2025.

4.15. Stichting Student Consultancy Group

The organization Stichting Student Consultancy Group:

- belongs to the Opinion Forming cluster;
- did not apply for an activity grant last year;
- is applying for a €o activity grant for this year;
- is not applying for housing this year;
- submitted their application in time and in full.

Assessment Activity Grant

The CUOS has assessed that the Stichting Student Consultancy Group:

- DOES meet the general conditions;
- DOES conduct a clear and consistent financial policy;
- HAS NOT demonstrated a financial need for support from the CUOS.

Decision Activity Grant

The CUOS has decided NOT to allocate an activity grant to Stichting Student Consultancy Group for the year 2024. After several attempts to contact Stichting Student Consultancy Group through e-mail, phone, and website, the CUOS found that the organization is unreachable. In addition, the financial need was not clearly presented due to the absence of a budget and lack of a revenue specification. Moreover, Form B was incomplete and did not specify the amount requested by Stichting Student Consultancy Group.

4.16. TEIMUN

Organization

The organization TEIMUN (The European International Model United Nations):

- belongs to the Internationalization cluster;
- received €8,000 of a requested €8,000 activity grant last year;
- is applying for a €10,000 activity grant for this year;
- is applying for housing for this year;
- submitted their application in time and in full.

Assessment Activity Grant

The CUOS has assessed that TEIMUN:

- DOES meet the general conditions;
- DOES conduct a clear and consistent financial policy;
- HAS spent last year's activity grant effectively;
- HAS demonstrated a financial need for support from the CUOS.

Decision Activity Grant

The CUOS has decided to allocate €10,000 to TEIMUN for 2024. The CUOS grants this amount for the purpose of running GrunnMun and TEIMUN. However, TEIMUN was short a zero on their Form B, but we based this amount on their application specified by their budget.

Assessment Housing

The CUOS has assessed that TEIMUN:

- HAS demonstrated a need for housing.

TEIMUN organizes some major activities on an annual basis. These activities come with a significant administrative burden. There is a workspace from which activities can be organized. TEIMUN does not have any claim on space from a faculty and does not have the resources to rent or purchase the space themselves. Moreover, TEIMUN contributes to a positive image of the University. The space TEIMUN currently receives through the CUOS is well used.

Decision Housing

The CUOS has decided to allocate 2 workspaces to TEIMUN in room 208 at Oude Kijk in 't Jatstraat for the year 2024-2025.
