Fact Sheet: Application and Admissions

PROGRAMME DETAILS

The Master in PPE is a one-year programme comprising 60 ECTS. The programme is taught in English. Our academic year runs from September 1st until June 30th. Enrolment is September 1st. The application deadline is May 1st for non-EU/-EEA students as well as for EU/EEA students.

ADMISSION REQUIREMENTS AND DOCUMENTS

To apply, please provide us with the following information and documents:

- Copy of bachelor certificate or proof of enrolment including expected graduation date: The programme is open to students with Bachelor degrees in PPE, political science, and economics, as well as to students with Bachelor degrees in other related fields, such as international relations, history, sociology, or psychology, provided they demonstrate a sufficiently close fit with PPE or one of its subdisciplines. NB: Having sufficient background in one's Bachelor is a necessary but not a sufficient condition for admission.
- Academic transcript: We expect applicants to have at least an average score of 7.5 out of 10 on the Dutch grading system in their Bachelor's (7.5 on the Dutch grading system roughly corresponds to an A-/B+ in the US system). If the programme involved a thesis, we also expect at least a 7.5 on the Dutch grading system. The admissions office will check how far an international candidate's GPA corresponds to our requirements on the Dutch grading system.
- Curriculum Vitae (CV)
- Motivation letter (between one and three pages): please explain why you wish to study our PPE Master – where applicable also in context of your long-term plans – and what qualifies you for the programme.



- Writing sample (between 3,000 and 10,000 words): This can be your Bachelor thesis or a paper on a relevant subject.
- Proof of English proficiency: you will need to prove your proficiency in English through one of the following
 - IELTS: minimum overall score 7.0 with no band lower than 6.5;
 - TOEFL: at least 100/120 overall score, with section scores being at least 22 for both reading and listening, 26 for speaking, and 24 for writing (our institution code is 7191).

This language requirement does not apply if:

- you are a native speaker and have completed your secondary education in any one of the following countries: Canada, USA, UK, Ireland, New Zealand, Australia
- you have completed your bachelor education in any one of the following countries: Canada, USA, UK, Ireland, New Zealand, Australia

HOW TO APPLY

International students

International applicants first register in Studielink, transfer the application fee and then complete their application in the progress portal. In order to do this, visit <http://www.rug.nl/howtoapply> and follow the steps.

Students with a Dutch degree

Applicants with a Dutch Bachelor degree first register in Studielink and then send their application files to ppe@rug.nl. Visit <https://www.rug.nl/education/master/nederlandse-studenten/aanmelding-en-inschrijving/> and follow the steps.

ADMISSIONS PROCEDURE

After reviewing all applications, the Board of Admissions will admit some students directly and reject some students directly. Other students will be invited for an interview (typically online). In an interview, the Board of Admissions will address issues such as motivation, ambition, skills and general fit with the PPE programme.

We aim to make decisions within two weeks, although decisions can sometimes take up to one month after the application deadline (see below). Where possible, we consider early non-EU/EEA applicants earlier.



There are three possible outcomes of your application:

- not admitted (we will motivate our decision),
- conditionally admitted (there are conditions that are to be fulfilled), or
- unconditionally admitted.

Once admitted, students will receive a reading list on topics of the PPE subdisciplines Philosophy, Politics and Economics.

- Non-EU/EEA students*: **May 1st**
- EU/EEA students: **May 1st**

* We advise non-EU students to apply even earlier and use the deadline of the preceding admission moment, as acquiring visa and other documents is often time-consuming.
