SECTION 1 GENERAL PROVISIONS

Article 1.1 – Applicability

These Teaching and Examination Regulations comprise a Part A and a Part B. This degree programme-specific Part B supplements Part A, which contains general stipulations for the teaching and examinations of the Bachelor's degree programmes taught at the Faculty of Arts, hereinafter referred to as **the Faculty**. Part B contains stipulations that specifically concern the Bachelor's degree programme in **Arts, Culture and Media**.

SECTION 2 QUALIFICATIONS

Article 2.1 – Admission to the programme with profile requirement

Without prejudice to the provisions of Article 2.1. of Part A of these Teaching and Examination Regulations, the following supplementary requirements apply to this degree programme: N/A.

Article 2.2 – Educational deficiencies

- 1. Deficiencies in educational qualifications in the subjects listed below may be compensated for by passing the relevant examinations at the level of the VWO final examination to the satisfaction of the Admissions Board: N/A.
- 2. Under certain circumstances, the Admissions Board can request a university lecturer in the relevant subject to arrange one or more tests.

Article 2.3 – Language requirement for foreign certificates

- 1. Students who have been admitted to a degree programme on the basis of a foreign certificate or degree may be required by the Admissions Board before registration to pass a Dutch or English language test, depending on the language of the chosen specialization, to be administered by an agency stipulated by the Board.
- 2. The Dutch language proficiency requirement can be met by passing the state examination in Dutch as a Second Language (NT2-II).
- 3. The English language proficiency requirement can be met by passing an examination in English at the level of the dutch VWO final exam or by passing the TOEFL with a score of at least 86 (with a minimum score of 20 for all components) or an IELTS-score of 6.5 (with a minimum score of 6.0 for all components), or by presenting a Certificate from the University of Groningen Language Centre.

Article 2.4 - Starting date

Notwithstanding the provisions of Article 2.7 of Part A, the following additional requirement applies to this degree programme:

Students who have previously been enrolled in this degree programme or who wish to start in a higher year may apply to the Admissions Board for permission to start on a date other than 1 September. The Admissions Board will grant permission for an alternative starting date if the specific course units that the student in question wishes to follow start on this date and if the student has satisfied the entry requirement for these course units.

Article 3.2 – Language

- 1. The degree programme is taught in *Dutch and English*. OCACYS and the degree programme descriptions set out which course units are taught in Dutch and which in English. In addition, in some course units the lectures are taught in English and the seminars in both English and Dutch. The timetable will indicate which groups are taught in which language. Furthermore, the course manuals will indicate the languages students can use for written assignments, exams and other tests.
- 2. The thesis/final assignment must be written in English or Dutch. A thesis/final assignment may only be written in a language other than English or Dutch if the Board of Examiners has given permission to do so.

Article 3.3 – Contact hours

- 1. The propaedeutic phase of the degree programme comprises a minimum of 480 contact hours a year.

Article 5.1 – Structure of the post-propaedeutic phase

1. The post-propaedeutic phase comprises the following course units with their related student workloads:

^{*2} Students following the English taught Bachelor's degree programme will follow the course unit Introduction to Audiovisual Arts B. Students of the Dutch track follow Introduction to Art Worlds (Inleiding Kunstwerelden).

^{*3} Choice of Film, Music, Theatre. The course units Film and Music will be taught in English only.

^{*4} Choice of Film, Music, Theatre, Literature (ETC), Modern and Contemporary Visual Arts (Art History). The course units Film, Music, and Modern Visual Arts will be taught in English only. Modern and Contemporary Visual Arts and Literature are not taught by the KCM department itself but by the department of History of Art and Architecture and that of European Languages and Cultures, respectively. These course units may be offered as a single 10 ECTS course unit rather than two course units worth 5 ECTS each.

SECTION 8 TRANSITIONAL AND FINAL PROVISIONS

Article 8.1 – Amendments

- 1. Any amendments to Part A of these Regulations will, after due consultation with and if necessary upon the approval of the Faculty Council, be confirmed by the Faculty Board in a separate decree.
- 2. Any amendments to Part B of these Regulations will, after due consultation with the Programme Committee and the Faculty Council and if necessary upon the approval of the Faculty Council, be confirmed by the Faculty Board in a separate decree.
- 3. Any amendments to these Regulations will not apply to the current academic year, unless it may reasonably be assumed that the amendment in question will not harm the interests of students.
- 4. In addition, an amendment may not influence any other decision concerning a student taken by the Board of Examiners under these Regulations to the disadvantage of students.

Article 8.2 – Publication

- 1. The Faculty Board will duly publish these Regulations, any rules and guidelines formulated by the Board of Examiners, and any amendments to these documents.
- 2. Copies of the documents referred to in Article 8.2.1 are available from the Faculty Office. These documents can also be found on the Faculty website via the Student Portal.

Article 8.3 – Date of commencement

These Regulations will take effect on 1 September 2016.

Overgangsregeling derde jaar bachelor KCM

Met ingang van het seizoen 2016-2017 wordt het programma van de Bachelor KCM gewijzigd. Dit kan consequenties hebben voor studenten die in 2013 of eerder met de opleiding zijn begonnen omdat sommige vakken verdwijnen en andere vakken in een ander semester gegeven zullen worden. In onderstaande tabel wordt aangegeven wat de consequenties zijn.

Voor alle vakken in het derde jaar (m.u.v. de bachelorscriptie en Kunst in Praktijk) zal in het seizoen 2015-2016 een extra (derde) tentamenkans worden aangeboden. Alleen studenten die aan beide reguliere tentamenkansen hebben deelgenomen worden tot deze derde kans toegelaten. Indien studenten niet aan één van de reguliere kansen hebben kunnen deelnemen of indien zij van mening zijn dat zij hierdoor benadeeld worden, kunnen zij de examencommissie om toegang tot de derde kans vragen. Dit dienen zij tijdig te doen, d.w.z. ruim voor de datum van de derde kans zoals die door de docent van het betreffende vak wordt bekend gemaakt.
