Biography:

In have completed a an applied science study in land- and water management (HBO), obtained a master's degree in social (environmental) geography at the Radboud University in Nijmegen (RUN) and finalised a PhD in Policy Sciences at this University on the topic of collective sustainable behaviour of farmers. I worked at various academic and non-academic organisations, including the Ministry of Agriculture Nature & Fisheries (LNV), The Telos Centre of Sustainability in Tilburg, the School for City and Regional Planning at Cardiff University, and the Rural Sociology Group of the University of Wageningen.

I currently work as Research Director and full Professor Socio-Spatial planning at the Faculty of Spatial Sciences of the University of Groningen. I also manage the Expertise team 'Engaged Society' within the Department of Spatial Planning, and the Environment supervise PhD researchers, supervise bachelor and master students' theses and teach master students within the master Society, Sustainability and Planning. My research currently focuses on 'transformative collective citizen initiatives and community responses to climate change' in the Netherlands and Europe. My work centres around sustainable place-based development and the 'human factor' in place-shaping, addressing questions such as how and why collective civic initiatives and communities contribute to spatial transformation, sustainability and a more favourable institutional setting. Relevant research topics are: civic engagement, leadership, energy transition, sustainability, resourceful communities, place-based development, self-governance, values and coalitions.

I participated in the (UN) international Climate Week in Groningen and co-authored the recent plan for the Climate Adaptation Platform in the Northern Netherlands (CAP). I am member of the Scientific Board of the RUG School Sustainable Society and the School on Energy and Climate. Currently I am member of the national Platform 'Collectieve Kracht' and active within the Research Committee of the international Regional Studies Association (RSA). I was one of the initiators of the RSA Research Network 'The Place of Leadership in Urban and Regional Development' and I have been an editorial board member of the journal 'Sustainability Science'. I was involved in the European COST Action IS1007 on cultural sustainability. I participated in conferences of various research networks, for example RSA, ESRS, AESOP and Transformations to Sustainability.

I was involved in several EU projects: DERREG, EUWelNet and GLAMUR, the INTERREG IVB project on 'Rural Alliances', and the INTERREG IIIB project 'LIFESCAPE-YOUR LANDSCAPE'. I co-coordinated the Marie Curie ITN program SUSPLACE ,and was co-initiator/author and partner of the Marie Curie ITN program RECOMS on resourceful communities. Both Marie Curie ITN programs hosted 15 Early-Stage Researchers and led to a variety of outputs, e.g.: training, books on co-creative methods, a MOOC on careful scholarship and policy briefs. I have edited several books, on Passion (2009), Vital Coalitions (2010), Leadership (2012), and the role of Culture in Regional Development (2015), (co)authored many peer-reviewed scientific articles and book chapters, and am reviewer of articles in various journals.
