

**Please note:** if you apply on the basis of a Dutch VWO diploma, the below-mentioned requirements do not apply to you.

### English-taught bachelor

- **BSc Medicine - Global Health** (maximum 110 places available for both Dutch and international students – depending on the division of preferences for Learning Communities)

For the English-taught Learning Community of the BSc Medicine, candidates must provide adequate evidence of proficiency in English. We accept the following tests:

IELTS (Academic)	6.5 - minimum score of 6.0 on each section
TOEFL IBT (internet-based test)	92 - minimum score of 21 on each section
Cambridge English Qualifications General and higher education	Advanced (CAE) <a href="#">C1 Advanced</a> Proficiency (CPE) <a href="#">C2 Proficiency</a>

#### Please keep in mind

- The test scores *cannot* be older than two years (except for the Cambridge English certificates).
- The modality required is 'academic'.
- You may apply for a degree programme while you have not yet taken an English test or while your test score is still insufficient. Should you be admitted, then your admission will be conditional with (one of) the condition(s) for final admission being that you take and pass a (new) test. Please inform the Admissions Office of the date on which you are planning to take such a test.
- We do not accept institutional TOEFL tests.
- Please note that TOEFL MyBest Scores are not considered in the Admissions procedure.

#### Exemptions

You are only exempted from providing your proficiency in English, if you:

- a (to be obtained) upper secondary qualification obtained in one of the following countries: USA, UK, Ireland, New Zealand, Australia, Canada (English speaking provinces/territories), Antigua and Barbuda, The Bahamas, Barbados, Belize, Grenada, Guyana, Jamaica, Trinidad and Tobago, St Kitts and Nevis, St Lucia and St Vincent and the Grenadines and meet our general end level requirements for that specific qualification;
- a (to be) completed Bachelor's programme in one of the following countries: USA, UK, Ireland, New Zealand, Australia, Canada (English speaking provinces/territories), Antigua and Barbuda, The Bahamas, Barbados, Belize, Grenada, Guyana, Jamaica, Trinidad and Tobago, St Kitts and Nevis, St Lucia and St Vincent and the Grenadines;
- at least 3 (to be obtained) academic GCE A2-level certificates with grades A\* to C from an accredited British examination board;
- an (to be obtained) International Baccalaureate diploma, with English as the medium of instruction;
- a (to be obtained) European Baccalaureate diploma from a European School or one of the Accredited European Schools and have (completed) English as an L1 or L2 subject;
- a (to be obtained) French Baccalauréat Français Internationale (BFI) - British version;
- a (to be obtained) South African National Senior Certificate in combination with an IEB Advanced Programme Certificate in English (with minimum result 55% in case this is the only IEB AP certificate; otherwise with a passing grade) or in combination with an IEB Further Studies (Certificate) in English (with minimum result 55% in case this is the only IEB certificate; otherwise with a passing grade);
- (to be obtained) Singapore/Cambridge A-levels in at least 3 H2 and 1 H1 content\* courses (of which at least 1 course in a contrasting discipline) together with either the course General Paper or Knowledge and Inquiry (5 courses in total).

Certificate Dutch as a Foreign Language (Certificaat Nederlands als Vreemde Taal(CNaVT)) – STRT en EDUP profielen - minimum B2-level
<a href="#">C-Test bij ons Talencentrum</a> (only possible in case you are a Dutch nativespeaker)

You are only exempted from providing your proficiency in Dutch, if you:

- apply on the basis of a (to be obtained) IB diploma with 'Dutch A' (SL or HL);
- apply on the basis of three (to be obtained) GCE A-levels from one of the British examination boards, including an A-level Dutch
- apply on the basis of a (to be obtained) Belgian Diploma van Algemeen Secundair Onderwijs (ASO)
- apply on the basis of a Dutch havodiploma (in combination with a (to be obtained) HBO propaedeutic certificate or another qualification leading to vwo-equivalency)
